# PAC UPDATES

## 221(G) ISSUES: ITSERVE'S SUCCESSFUL EFFORTS WITH THE U.S CONSULATES

As you are aware, ITServe began engaging with the U.S. Dept. of State (Consulates) on 221 (g) issues in early 2022. We continued explaining the court ruling on Proof of Projects/Client letters and saw significant results.

- **Visa Revalidation within the U.S.A:** Dept. of State has announced that it is considering the resumption of renewing visas (H & L Categories) in the U.S. We put a lot of emphasis on this topic in our interactions with lawmakers during our 2022 Capitol Hill Lobby Day (July 11, 2022).
- **221(g)s:** U.S. Consular offices in India have removed all prohibited items from 221(g) letters pursuant to the Federal Court's decisions on Proof of Projects/Client letters. Expecting the new 221 (g) template will reflect these changes.
- **A number of 221(g)s issued in the past requiring client letters are still pending.** We're seeing more 'Administrative Processing' 221(g)s now. We still need to resolve them quickly.

**Our General Counsel, Mr. Jon Wasden, is working on filing a lawsuit on the following:**

1. Resolve all the old 221 (g)s.
2. Force the Department of State for quicker policy change globally for client letters and 'Administrative Processing' 221(g)s.

**Once we are successful with the above lawsuit, it will help everyone across the U.S. Consulates worldwide. Please continue to send your 221(g)s as you receive them to PACAdmin@ITServe.Org to strengthen the lawsuit.** Please stay tuned for more updates in the weeks and months ahead. We thank you for your support and trust bestowed on us.

## U.S. Citizenship and Immigration Services Fee Schedule and Changes to Certain Other Immigration Benefit Request Requirements

The Department of Homeland Security (DHS) proposes to adjust certain immigration and naturalization benefit request fees charged by U.S. Citizenship and Immigration Services (USCIS). USCIS conducted a comprehensive biennial fee review and determined that its costs have increased considerably since its previous fee adjustment due to expanded humanitarian programs, higher demand, increased processing times, and a need for more USCIS employees

## USCIS NOW REQUIRES SEPARATE CHECKS FOR FILING FEES

Practice Alert: AILA Doc. No. 23020103 | Dated February 1, 2023

AILA has received reports from members who have had applications rejected where a single payment was submitted that included fees for the form and biometrics. Reports include Form I-821D/Form I-765 (DACA) and Form N-400.

Despite USCIS's general instructions that biometrics fees may be paid with the fee for the form they accompany, specific filing fee guidance on USCIS.gov includes the following notice:

Pay each filing fee separately. We are transitioning to electronically processing immigration benefit requests, which requires us to use multiple systems to process your package. Because of this, you must pay each filing fee separately for any form you submit. We may reject your entire package if you submit a single, combined payment for multiple forms.

Additionally, at the moment, it remains unclear if the American Competitive and Workforce Act (ACWIA) fee required for Form I-129 will need to be paid individually from the filing fee.

At this juncture, AILA recommends as a best practice that payments be submitted individually for each form or request, including payment for biometrics and ACWIA fees, until the information is clarified
