#### PRESIDENT, ITSERVE ALLIANCE

#### 1. What drew you to ITServe?

In 2016, my inner self was not happy with routine business transactions and was looking for volunteer work that could make me happy. ITserve was a God-sent opportunity. It was a group, where we had similar issues, challenges, and a lot of information exchange based on the experiences of many. It became like a family and my passion.

#### 2. As the current President, what is your vision for ITServe.

In my vision, I see ITServe creating a multiplier effect on society including economy and community. I see ITServe taking many initiatives including the protection of the interests of small businesses in IT, creating local employment, providing STEM education for underprivileged communities, and taking many other CSR initiatives.

In this process, ITServe will touch millions of lives and empower local employment and empower local communities. Our members have realized the value and strength of collective effort, knowledge sharing, networking. They have a big heart to give back to the community. ITserve is taking lobbying to the next level and is working with lawmakers very closely to introduce an ITServe Bill called HIRE ACT focused on high-skilled immigration and training. ITServe has launched ITServe Services which will focus on members' benefits including Insurance, M&A, and, Payroll Services.

#### 4. Can you share some of the major challenges you have faced thus far and how you manage them.

The first Quarter has gone very well thanks to all the help from GB, EB, Chapter Presidents, and Core Teams, as well as all the members and the sponsors. The Chapters and National team are working on high momentum with Chapter Meetings, Kick Offs, with Regional Meetings lined up throughout the year. Challenges on the horizon include our members facing 221 G, FDNS site visit, and Immigration Fee increase. ITServe has hired General Counsel Jonathan, and he is addressing all these concerns. Looming recession is another worry and we are trying to prepare for through education offered to members and working on internal cost control at ITserve.

## 5. At the end of your presidency, how would you want to be remembered by ITServe and the successive leadership and members?

I am a volunteer and would like to be remembered as a passionate and dedicated ITServe Volunteer. ITServe is very fortunate to have hundreds of volunteers, who are giving many precious hours to this great collective cause.

#### 6. Any other thoughts, you want to share with ITServe members/It industry members

My message to ITServe members is that - You are all Ambassadors of ITServe. Wherever you go, you should talk about the great work ITserve has done in simplifying the highly skilled immigration, which has benefited the whole IT Industry, including our members and their employees and all others in the IT Sector. You should talk about the excellent work ITServe is doing in CSR and specifically on STEM education. Let society know about the significant contributions we are making. Let each of us be a proud member of ITServe Alliance.

# SIVA MOOPANAR

DIRECTOR - POLICY ADVOCACY COMMITTEE (PAC)

#### 1. As the Director of ITServe Alliance Policy Advocacy Committee (PAC), enumerate the objectives:

Enhancing local employment and Innovation are the primary objectives of ITServe's Policy Advocacy. Innovation is very important for job creation and the economic growth of a country. We want the best and the brightest from around the world over here which triggers the technology revolution and jobs. Our country should be on top of the world for several hundred years.

#### 2. Are there any hurdles to achieving your objectives and how ITServe overcomes?

Yes, we have obstacles, not blaming anyone, but we are achieving them via Social Media campaigning, liaising with Government, STEM education, CSR activities, litigation etc.

#### 3. What are some of the initiatives you have led as the Director of PAC?

a. We initiated the HIRE ACT bill (High Skilled Immigration Reform for Employment), introduced at the Congress in December 2022. Innovation, STEM education, and avoiding brain drain are the highlights of the bill.

- Remove the STEM graduates of U.S Master's Degree and/or Ph.D. holders from the H1B CAP quota and make it unlimited to retain the top talent & innovation in the Country.
- STEM (Science, Technology, Engineering, and Math) Program to promote the "American Ingenuity Account" to fund State-administered grants for STEM education and worker training.
- Enhance the current H1B CAP Quota limits at least 65,000 to 130,000/ year.

b. With the support of ITServe leadership and members, we established "ITServe Connected PAC".

# 4. Recently, several IT groups have laid off thousands of employees. What are the efforts made to ensure that they do not lose their visa status, and this prevents deportation?

Small and medium-size IT Service companies in the US played a vital role in hiring and upskilling most of the tech Talents who got laid off during the 2000 Dot.com burst and the 2009 great recession. These valiant efforts from our member companies not only avoided brain drain but also several hundreds of those talents became entrepreneurs and created millions of jobs in this country.

Considering that in mind we sent letters to President Biden and the Legislatures, requesting to extend the grace period for the laid-off talents to 180 days, to stay in this country.

5. This week, during a meeting with Indian American leaders, Senator Charles Schumer, Senate Majority Leader assured that the Green Card backlog will be cleared soon. He believes highly skilled workers such as physicians should be given direct Green Cards instead of H1 or J1 visas and he will work on making it happen. Your comments?

ITServe has continuously supported to remove the Green Card backlog for high-skilled immigrants and will do so in the future as well. They have been waiting for several years to get GC and some of them are going back to their home country, which is a huge loss to our country. Not only that but their kids are also getting affected. When they turn 21 years old, either they must switch to a student visa or go out of the country.

#### 1. What is your role as the Director of PR for ITServe?

## ITServe Alliance Inc., PAG (Policy Advocacy Group) Updates

### LITIGATIONS FILED:

A. 221(g):

ITServe General Counsel, Mr. Wasden has filed the lawsuit against the Dept. of State (DOS) to resolve all the pending 221(g)s issued by U.S Consulates overseas and compel the DOS to address and resolve through a policy change and communicate to all the consulates globally to that effect.

Thanks to ITServe's initiative, U.S Consular offices in India have now removed all the prohibited items from 221(g) letters w.r.t Client letters, itinerary & employee-employer relationship pursuant to Federal Courts decision. However, there are several 221(g)s issued in the past requiring the above, besides the 221(g)s issued for Administrative Processing. ITServe is planning to file an addendum to the already filed 221(g) litigation with the additional 221(g) denials in the next several days. Please feel free to email PACAdmin@itserve.org, if you have any 221(g)s to address and resolve.

#### B. EXTENSION OF GRACE PERIOD FROM THE CURRENT 60 DAYS TO 180 DAYS:

As you all know, USCIS has allowed the non-immigrants who are on HIb visas, got laid off due to the recent unprecedented job losses allowed to remain in the country for 60 days and seek alternative employment to continue their stay. This period of 60 days is too short in the current environment, hence ITServe has requested the Administration to extend this current grace period of 60 days to 180 days for the laid-off HIB workers to find alternative employment, continue their stay, and support their families. We have sent letters to President Biden and the Legislatures to that effect and hoping to hear from them soon.

Small and medium-sized IT Service companies in the US played a vital role in hiring and upskilling most of the tech Talents who got laid off during the 2000 Dot com burst and the 2009 great recession. These valiant efforts from our member companies not only avoided brain drain but also several hundreds of those talents became entrepreneurs and created millions of jobs in this country.

### **COMMENTS ON PROPOSED H1B FEE INCREASE:**

As you all are aware, USCIS issued a proposed rule to adjust certain immigration and naturalization fees which will have an adverse effect on member companies and their ability to take on those extra costs. Our legal counsel has done extensive research on the proposed fee change and submitted the comments with the relevant data on behalf of ITServe on March 13, 2023. We hope USCIS will consider those comments submitted based on the facts and the historic data presented in either minimizing the fee adjustment or remaining unchanged. Please stay tuned for more updates on this initiative in the coming days.

### PERM DENIALS:

We have been hearing recently that a lot of PERM cases have been denied in recent days. ITServe is proactively collecting data from the member companies to evaluate and decide the course of action. ### SIMEIO SOLUTIONS & 50/50 CASE:

(\$4,00 fee refund – change of status of employees from OPT to HIB)

ITSEVE is awaiting final judgment as the deliberations were complete on both sides. Facts and merits are on our side. If we are successful, it will be a game changer for the industry as a whole and will help businesses to stay focused on creating more employment than being stuck in administrative matters of filing amended petitions within the HIB approval period and save on the related costs etc.,

### **UPCOMING LITIGATION INITIATIVES:**

FDNS Site visits are another major issue that we are facing in recent months. It has caused enormous inconvenience and scare among employees and employers. Our legal Counsel is planning to file litigation on these unjust practices based on the facts in the coming weeks. Please stay tuned for more details in this regard to be made available to all the members.
